Item 1: Call to Order and Roll Call:

The South Carolina Governor's School for Science and Mathematics held its Board of Trustees Meeting on November 16, 2023, in person and via Zoom Video Conference. The meeting was called to order by Chairman Bob Brown at 12:08 p.m.

Item 2: Approve the minutes of the Regular Board of Trustees meeting on September 8, 2023. Since no quorum of the Board was established, the minutes of the regular Board of Trustees meeting on September 8, 2023, were also tabled until the next regularly scheduled meeting.

Chairman Brown requested that the agenda be amended to discuss item #4, Education Policies and Practices Committee Report.

Item 4: Education Policies and Practices Committee Report

Dr. David Tedeschi presented his report on behalf of the Education Policies and Practices Committee. Dr. Tedeschi updated the committee on the discontinuance of the STEM Foundation pilot. However, since no quorum was present, voting on approving the discontinuation of recruitment for new cohorts for the STEM Foundations Pilot for 2025 was tabled until the next meeting.

Item 3: President's Report - Information Only

Mr. Dorsel provided updates on recruitment and enrollment, the Vice President of Enrollment Management vacancy, and marketing efforts through commercials and podcasts. He also discussed the research colloquium, the GSSM community meetings, summer outreach partnerships, and impact, the SC Nexus Tech Hub, and alumni's impact on South Carolina. Item 5: Finance, Facilities, and Operations - Information Only

Item 7: Faculty Senate Update

Dr. Roberto Robles-Valencia provided an update on behalf of the Faculty Senate. He invited the Board of Trustees to campus to observe a class.

Chairman Brown requested that the agenda be amended to move item #9, Break.

Item 9: Break

Chairman Brown requested a 9-minute break at 1:11 p.m. and reconvened the meeting at 1:20 p.m.

Item 8: Student and Faculty/Staff Update

Breanna Sherwood, a member of the Class of 2024, shared her reasons for applying and deciding to attend GSSM. She also talked about her research experience at the University of South Carolina, where she created hydrogels and sensors. Furthermore, she discussed her future academic goals, the colleges she aspires to attend, and the different career paths she has to choose.

During his discussion, Dr. Christopher Roberts discussed his journey to GSSM, his desire to teach at the institution, and the various available research courses.

Item 10: New Business - Information Only

Mr. Getter raised an issue regarding a student who sent two emails to the GSSM community on behalf of a student group without obtaining permission. The first email was not reviewed by the faculty or staff and included a political message urging students to wear green to support Palestinian civilians affected by the conflict. Mr. Dorsel clarified that the student intended to express empathy toward the people suffering due to the ongoing conflict. However, it was emphasized that supporting any political agenda is not in line with GSSM's policy.

Item 11: Approval of the Consent Agenda - Information Only

Due to the absence of a quorum, the voting for approving the Consent Agenda was postponed until the next regular meeting for discussion.

During the meeting, Mr. Getter talked about the Enrollment report and emphasized the importance of the school consistently identifying students as male or female. He also brought up the Outreach SPARK virtual afterschool program, which aims to involve students in STEAM studies and is specifically designed for sixth through eighth graders. Mr. Getter suggested creating a 15-30-second commercial to promote the program.

Chairman Brown stated there were no topics to discuss.
